First Quarter 2021 Key Messages

Petco delivered record revenue growth quarter with 1.2 million net new customers to sticky multichannel platform

Pet adoptions remain strong in 2021 providing an annuity for years to come

Pet Care Center revenue growth of 26% was driven by strong retail traffic, AOV and average basket growth

Our digital offerings and delivery advantages (BOPUS and Same Day Delivery) are driving customer acquisition and strong retention

Services and Vet are poised for multi-year growth driven by our vet hospital expansion and strength in grooming and training

Revenue growth of 27% in Q1'21 is translating into stronger 45% Adjusted EBITDA¹ and improved Adjusted EPS¹ performance

Significant deleveraging and reduction of interest expense drove reduced Net Debt¹ / TTM Adjusted EBITDA¹ ratio to 2.9x



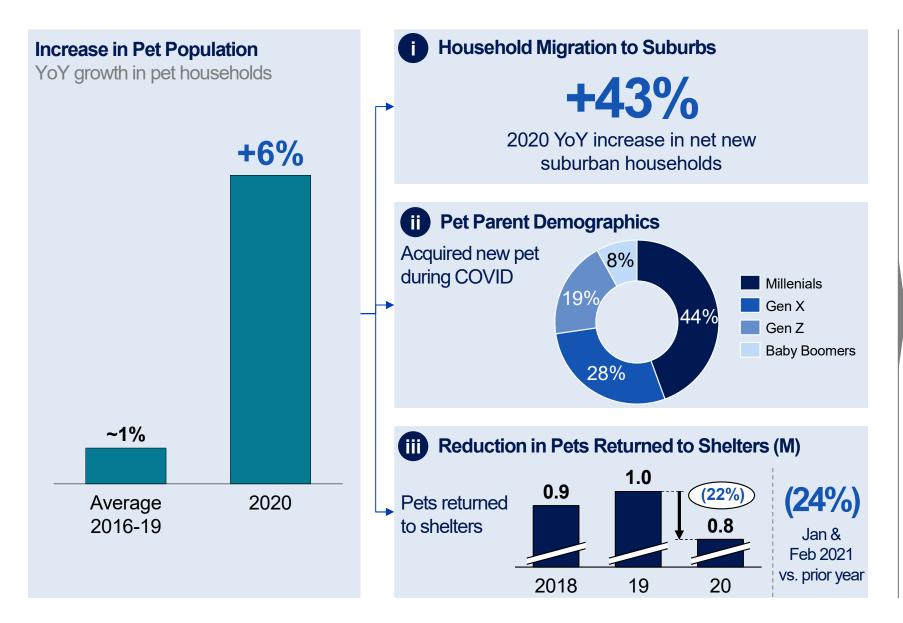

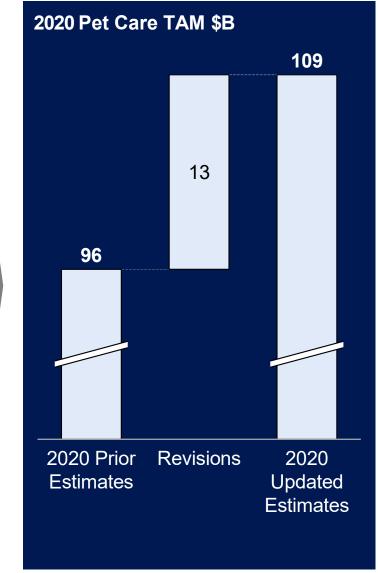

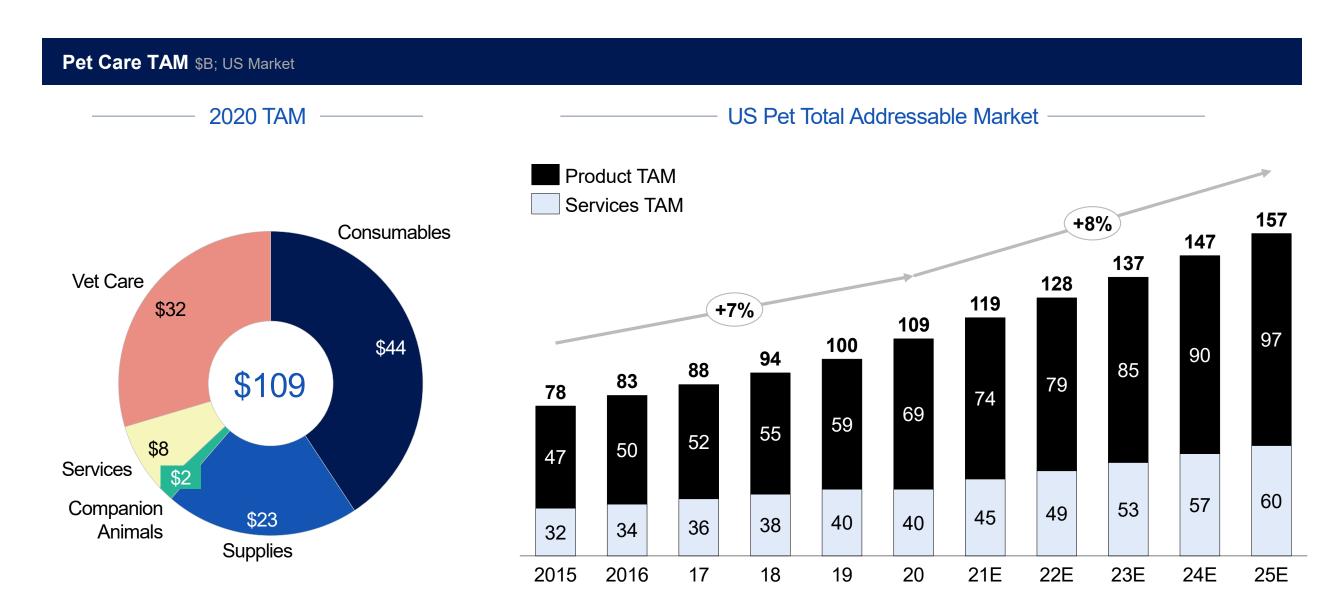

Q1 2021 Key Highlights

- Strong momentum with exceptional execution supported by tailwinds from a substantial increase in pet ownership continuing in 2021 and fueling multiyear category sales growth
- ▶ Q1'21 double-digit revenue growth versus prior year with 26%, 21% and 63% growth in Pet Care Centers, Digital, and Services & Vet respectively reflecting our complete pet ecosystem driven strategic transformation
- ► Gross margin expanded 32 bps driven by rate expansion across key business areas, offsetting mix pressure
- Revenue, gross margin expansion and expense leverage generated meaningful profit growth and cash flow
- Net leverage ratio decreased by almost two thirds

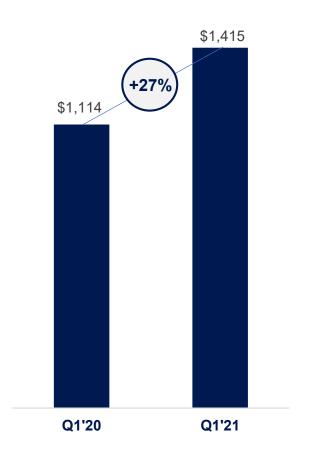

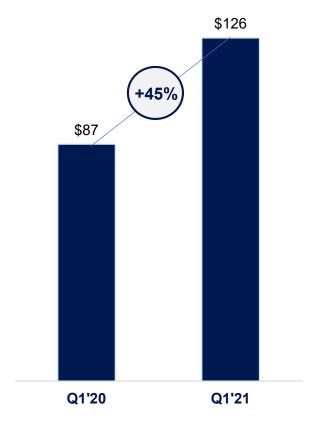

Adjusted EBITDA¹ (\$M)



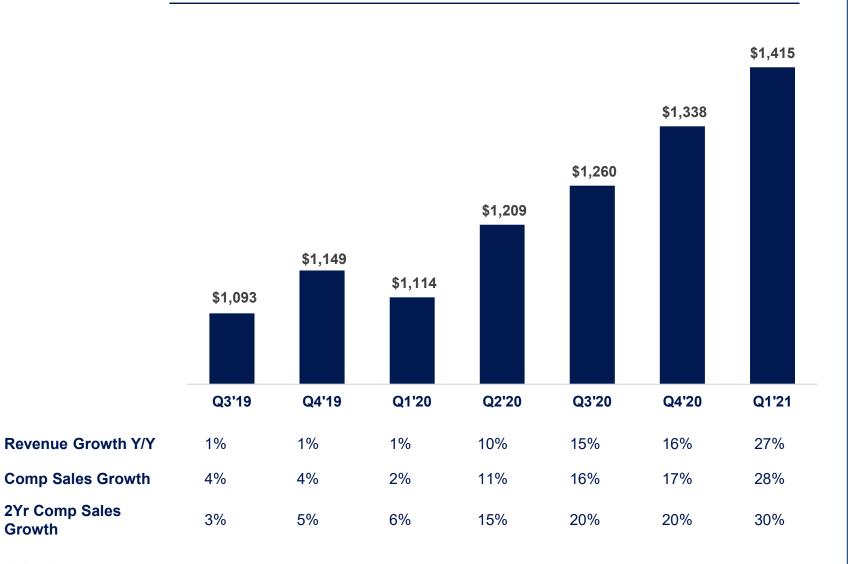


Q1 2021 Key Highlights

- ► Revenue grew 27% versus prior year with accelerating trends over the last year and drove 28% gross profit growth
- Strong revenue trends and expense leverage drove 45% Adjusted EBITDA growth while we meaningfully invested in:
 - Sustained future growth opportunities like branding and customer acquisition marketing
 - Our partners through bonus measures and other rewards

Q1 2021 Key Highlights

- ► Revenue growth continued to accelerate on a quarterly basis
- ▶ Pet Care Centers reached 26% growth with higher retail demand and traction on strategic initiatives
- ► Digital revenue increased 21% or 129% on a two-year stack reflecting our strategic investments and customer fulfillment advantages
- Services and Vet revenue grew by 63% with return of demand in grooming and training with vet revenue almost doubling

Q1 2021 Key Highlights

- ➤ Stronger than expected Q1'21 free cash flow of \$68M improved significantly due to robust business performance
- ► Capital expenditures of \$47M were primarily associated with vet hospital scaling and investments in IT infrastructure and innovation
- ➤ Significant reduction of net debt and leverage was driven by the IPO transaction, related recapitalization and strong free cash flow generation

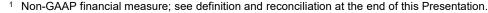

Non-GAAP Measures

The following information provides definitions and reconciliations of the non-GAAP financial measures presented in this Earnings Presentation to which this reconciliation is attached to the most directly comparable financial measures calculated and presented in accordance with generally accepted accounting principles (GAAP). The company has provided this non-GAAP financial information presented, which is not calculated or presented in accordance with GAAP, as information supplemental and in addition to the financial measures presented in the Earnings Presentation that are calculated and presented in accordance with GAAP. Such non-GAAP financial measures should not be considered superior to, as a substitute for or alternative to, and should be considered in conjunction with, the GAAP financial measures presented in the Earnings Presentation. The non-GAAP financial measures in the Earnings Presentation may differ from similarly-titled measures used by other companies.

Adjusted EBITDA: Adjusted EBITDA is considered a non-GAAP financial measure under the SEC's rules because it excludes certain charges included in net income (loss) calculated in accordance with GAAP. Management believes that Adjusted EBITDA is a meaningful measure to share with investors because it best allows comparison of the performance of the current period performance with that of the comparable period. In addition, Adjusted EBITDA affords investors a view of what management considers Petco's operating performance to be and the ability to make a more informed assessment of such operating performance as compared with that of the prior year. Please see the company's 10-K filed on April 5, 2021 for additional information on the reconciliation of Net Income (Loss) Attributable to Class A and B-1 Common Stockholders to Adjusted EBITDA. The tables on pages 15 and 16 of this Presentation reflect the calculation of Adjusted EBITDA for the thirteen weeks and trailing twelve months ended May 1, 2021 compared to the prior year quarter and twelve-month period ended May 2, 2020, respectively.

Adjusted Net Income and Adjusted EPS: Adjusted Net Income and Adjusted EPS: Adjusted Net Income and Adjusted EPS respectively) are considered non-GAAP financial measures under the SEC's rules because they exclude certain amounts included in the net loss attributable to common stockholders and diluted earnings per share attributable to Petco calculated in accordance with GAAP (net income (loss) and EPS respectively), the most directly comparable financial measures calculated in accordance with GAAP. Management believes that Adjusted Net Income and Adjusted EPS are meaningful measures to share with investors because they best allow comparison of the performance with that of the comparable period. In addition, Adjusted Net Income and Adjusted EPS afford investors a view of what management considers Petco's earnings performance to be and the ability to make a more informed assessment of such earnings performance with that of the prior year. The tables on page 17 of this Presentation reflect the calculation of Adjusted Net Income and Adjusted EPS for the thirteen weeks ended May 1, 2021 compared to the prior year quarter ended May 2, 2020.

Free Cash Flow: Free cash flow is a non-GAAP financial measure that is calculated as net cash generated by operations less cash paid for fixed assets. Management believes that free cash flow, which measures the ability to generate additional cash from business operations, is an important financial measure for use in evaluating the company's financial performance. Although other companies report their free cash flow, numerous methods exist for calculating a company's free cash flow. As a result, the method used by Petco's management to calculate free cash flow may differ from the methods used by other companies to calculate their free cash flow. The following table sets forth a reconciliation of free cash flow, to net cash provided by operating activities, which Petco believes to be the GAAP financial measure most directly comparable to free cash flow. The table on page 18 of this Presentation reflects the calculation of free cash flow for the thirteen weeks ended May 1, 2021 compared to the prior year quarter ended May 2, 2020.

Net Debt: Net Debt is a non-GAAP financial measure that is calculated as the sum of current and non-current debt, less cash and cash equivalents. Management considers this adjustment useful because it reduces the volatility of total debt caused by fluctuations between cash paid against the company's revolving credit facility and cash held on hand in cash and cash equivalents. Although other companies report their Net Debt, numerous methods exist for calculating a company's net debt. As a result, the method used by Petco's management to calculate net debt may differ from the methods used by other companies to calculate their Net Debt. The table on page 19 of this Presentation sets forth a reconciliation of Net Debt, to total debt, which Petco believes to be the GAAP financial measure most directly comparable to Net Debt. The table on page 19 reflects the calculation of Net Debt as of the period ended May 1, 2021 compared to the prior year quarter ended May 2, 2020.
